

**PAZIŅOJUMS
PAR APDROŠINĀŠANAS PORTFEĻA

Aetna Health Insurance Company of Europe DAC (“**AHICE**”) (juridiskā adrese: Alexandra House, 3 Ballsbridge Park, D04 C7H2, Ballsbridge, Dublinā, Īrija) plāno nodot visu savu apdrošināšanas līgumu portfeli (tostarp nedzīvības apdrošināšanas polišu portfeli, kas ietver 1. klases (Nelaimes gadījumi), 2. klases (Slimības) un 18. klases (Palīdzība) apdrošināšanas polises) (“**Nododamās polises**”) uzņēmumam AWP Health & Life SA, kas darbojas ar Īrijas filiāles starpniecību (“**AWP**”) (juridiskā adrese: 7 Rue Dora Maar, 93400 Saint-Ouen Sur Seine, Francija), ar Īrijas filiāli 15 Joyce way, Park west Business Park, Nangor Road Dublin 12, Dublinā, Īrijā (“**Shēma**”).

2023. gada 7. novembrī Īrijas Augstā tiesa apstiprināja Shēmu. Shēma stāsies spēkā 2023. gada 1. decembrī. Pēc Shēmas pabeigšanas AWP pārņems visas tiesības un pienākumus saskaņā ar AHICE noslēgtajām Nododamajām polisēm, tostarp, bet ne tikai, tām Nododamajām polisēm, ar kurām saistītie riski atrodas Latvijā. AWP turpinās sniegt tos apdrošināšanas pakalpojumus saskaņā ar Nododamajām polisēm, kurus pašlaik nodrošina AHICE. Nododamo polišu noteikumi un nosacījumi paliks nemainīgi.

**NOTIFICATION
OF TRANSFER OF INSURANCE
PORTFOLIO**

7 November 2023

Aetna Health Insurance Company of Europe DAC (“**AHICE**”) (legal address: Alexandra House, 3 Ballsbridge Park, D04 C7H2, Ballsbridge, Dublin, Ireland) intends to transfer its entire insurance contracts’ portfolio (including a portfolio of non-life insurance policies in Classes 1 (Accidents), Class 2 (Sickness), and Class 18 (Assistance)) (“**Transferring Policies**”) to AWP Health & Life SA, acting through its Irish branch (“**AWP**”) (legal address: 7 Rue Dora Maar, 93400 Saint-Ouen Sur Seine, France), having its Irish branch office at 15 Joyce way, Park west Business Park, Nangor Road Dublin 12, Dublin, Ireland (“**Scheme**”).

On 7 November 2023, the approval for the Scheme was granted by the Irish High Court. The Scheme shall take effect on 1 December 2023. After the completion of the Scheme, AWP will take over all rights and obligations under the Transferring Policies concluded by AHICE, including but not limited to those Transferring Policies with risks situated in Latvia. AWP will continue to provide those insurance services under the Transferring Policies that are currently provided by AHICE. The terms and conditions of Transferring Policies will remain the same.
